Factsheet G6 Direct Payments

People who are eligible for services from Hertfordshire County Council can now have cash equal to the cost of services (a 'direct payment'), with which to buy their own support services if they prefer. Direct payments are available to people over 16 in their own right, to parents of a disabled child and to carers. A direct payment to carers comes in the form of a carers grant resulting from a carers assessment - see factsheet G3.

A direct payment to the person cared for aims to give people choice, flexibility and control over the support they receive. It allows them to choose whether to have all or part of their care package paid for by direct payments, or to continue to receive services directly provided by the county council as before.

Who is eligible for a direct payment?

The person must be:

- eligible for services from the County Council
- not restricted by Department of Health guidance (see 'Exclusions')
- willing and able to be in control of decisions about care and be able to manage direct payments, either alone or with assistance (if direct payments are for a child, the person with parental responsibility should manage them on the child's behalf)

Exclusions

Anyone who has given Power of Attorney to someone else, and that Power has been registered with the Court of Protection, cannot have direct payments from the date of registration. Certain people under Mental Health legislation are also excluded:

- People subject to a Guardianship order
- People covered by a supervised discharge from hospital
- People detained under mental health legislation, or on leave of absence from hospital
- Anyone conditionally discharged from hospital under home office restrictions
- Anyone receiving aftercare from hospital where there has been a compulsory court order for the care
- Any offender who as part of the treatment has to undergo treatment for a mental health condition or drug or alcohol programme
- Offenders released on licence and part of the licence is to undergo treatment

How to get a direct payment

Anyone already receiving services from the county council should contact their social worker to discuss the option of changing to direct payments. If care services are not yet in place, or there is no named social worker, contact Hertfordshire County Council (phone numbers below) to request an assessment or re-assessment, explaining that you are interested in direct payments.

How much will a direct payment be?

This is normally equivalent to the cost of the services that would be directly provided by the county council. Depending on the age of the person receiving the direct payment, and

their income / savings, they may have to contribute towards the costs of their support. In this case the direct payment will be reduced by this amount.

What can I use a direct payment for?

The social worker carrying out the assessment can give guidance on how to use the money. Examples of how direct payments have been used in the past include employing personal assistants, home carers, befrienders, paying for practical assistance in the home, buying day service activities or respite care. Direct Payments cannot be used to purchase local authority services, permanent residential and nursing care or for housing & NHS services.

Independent Living Fund (ILF)

The ILF is a trust set up by the government to provide cash payments to disabled adults, which they can use to purchase personal assistance. To find out if you qualify for the ILF, you should contact your social worker.
